Item 3. Open Session: 11 Residents

P. Murray- pond depth up to a certain amount. Clean harbor is going to cost a lot more then \$500. J. McCarthy will check with her husband for he worked for clean harbor. P. Murray will be in town Tuesday would like to pick up a copy of the plans. Tried to do it but he needed authority by the town Motion made by Selectmen J. McCarthy and 2nd by Selectman E. Hanson to give permission for P. Murray to pick up a copy of the pond design from Swell and give a copy to each Board member who wants one.

T. Lufkin- reported to the Board that the Middle Rd. bridge has a gap in the deck of the bridge approximately half inch wide in the middle of the deck you can look right down and see the water flowing in the stream. It is in a straight line. Thanked T. Lufkin for bring this to our attention. E. Hanson will get in touch with a cement worker and get their opinion if needed call MDOT

Item 4. Committee Reports:

- **a.** Planning Board / CEO: monthly report handed out
- **b. Future Fire Station Committee:** J. Dyer- email from USDA the documents have been approved the money is coming from D.C. The agreement will be put together, reviewed and signed. J. McCarthy asked to see them ahead of time.
- c. Recreation Committee/ Bradford Days Committee- J. McCarthy- Playground equipment that is on the side of the property line between the Community Center and the ball field. J. McCarthy took pictures and sent them to the Rec Chair, she still wants the equipment that was originally installed at the old Bradford Elementary School to be installed at the ballfield. J. McCarthy felt that the slide had a too big of drop on it. C. Oakes pointed out that the slide is most likely not going back up due to the way it was removed from the park years ago.

Motion made by Selectmen J. McCarthy and 2^{nd} by Selectman E. Hanson to allow the Rec Committee to place the playground equipment safely and to have the CEO approve the placement to the boundary lines.

- **d. Fire Department:** Chief reminded the Board that 1-72 will be out of service on Monday for it will be going in for some repair work.

He thanked R. Jack for doing the winter ground clean up at the fire house it looks very nice.

Asked about the camera at the skid tank. In that conversation it was decided to get a few cameras to cover the fire station doors J. McCarthy said there was no amount in the motion for the camera so we could order them for the fire station doors.

Bradford fire is now Dover and Milo 3rd alarm

- J. McCarthy asked the Fire Chief is the dumpster's position is ok now.
- **e. Road Commissioner**: Heavy Loads signs E. Hanson will remove all postings J. McCarthy asked about dividing the roads and cemeteries up as it was done last year. She will get a list out to them.

Grading- C. Oakes requested they do not go beyond box 187.

How are the grader operators charging by the hr. or mile? - E. Hanson said they are charging by the hour but keeping it to \$500 a mile it will average out over the season. Can you have them break the bill down to what hours are hours they have on each road not lumping it all together so we can keep track what is spent on each rd.

E. Hanson- the contact people do you want to change? No keep it E. Hanson and C. Oakes

Comment from Erik Hanson on the free bag of pavement patch- worked very well on Station Rd as you put it out you could see it spreading.

Hopkinson's prices: Pond Rd-1/2" shim, 1" overlay-\$95,000

Middle Rd. north end ½" shim, 1" overlay- \$27,000

Paving in and out of Middle Rd. Bridge- \$21,000 210 tons

Wilder Davis Rd.- beginning of the road does not include prep

work \$9,600

King Rd. needs to be dug out where the deep ruts are.

E. Hanson has been marking spots where there appears to be a need for gravel.

Motion made by Selectman J. McCarthy and 2^{nd} by Selectman E. Hanson to have a road meeting on May 22^{nd} @ 6pm to make a road plan but leave it open so they can discuss other things.

E. Nevells was informed about a tree down on Wilder Davis Rd. Called E. Hanson he went down and residents on the road was making it passable. R. Jack will go down later and move the tree off the road.

Gravel class- Thursday May 4th Brewer 8:00 to 3 pm. A. Hines is signed up to go. She has offered her seat if anyone else on the Board would like to go. No takers A. Hines, J. McCarthy and T. M will go.

Town Manager: After 53% of the toner used and 7 reams of paper and 9 hrs. of printing Town report was completed. It is on the web site. 2022 Annual Town report was put on the web last year. The office continues to be very busy. Missed my Local Health Officer class due to being interrupted too many times. Meet with Camden Bank and changed how they classify our accounts this gives us a better interest rate. They label them checking accounts but we will continue to use them how we have in the past as reserve and saving accounts. We also have the opportunity for short term CD's at a rate of 4%.

L. Surette – suggested due to the ink and time it takes to do the annual report would it be better to send it out to be printed.

Motion made by Selectman J. McCarthy and 2nd by Selectman E. Hanson that the Board proof read newsletters and the Town Report before being sent out.
