Item 1. Roads: gravel size for surface gravel 1 ½" minus

compacted with a vibrating roller

tapering 50 ft on each side of the project feathering the gravel

roads to be graded with a 4% crown before work is done to them

Several road areas were discussed that needed work on.

Reeves Road had 4 areas with varying projects on it

Middle Rd, King Rd, Atkinson, Rd, Marshall Rd, Station Rd, Williams Rd and Water's Ln all have areas marked out.

Roads that have pot holed and/ or are rough- Drake at the beginning, Gravy Ln, Wilder Davis Rd

Station Rd. has a couple of wash- out areas- 1 on the pavement the other on the gravel, Charleston Rd. also has a wash out

Winter salt sand mixture: front and back of the sand pile should be lighter for the roads are usually softer in the beginning and end of the season. The middle of the pile a bit heaver for the roads are now frozen.
